**ROAD TRAFFIC**

**The M3 Motorway (Junction 4A, Westbound Exit Slip Road)  
(Temporary Prohibition of Traffic) Order 2010**

*Made* - - - - *1st November 2010*  
*Coming into force* - - *20th November 2010*

WHEREAS the Secretary of State for Transport, being the traffic authority for the M3 Motorway and connecting roads, is satisfied that traffic should be prohibited on one of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

**1.** This Order may be cited as the M3 Motorway (Junction 4A, Westbound Exit Slip Road) (Temporary Prohibition of Traffic) Order 2010 and shall come into force on 20th November 2010.

**2.** In this Order:

“the motorway” means the M3 Motorway near Farnborough in the County of Hampshire;

“the slip road” means the road leading from the westbound carriageway of the motorway to the A327 at Junction 4A;

“works” mean carriageway repairs and all associated works on the motorway; and

“a works period” means a period of –

- (i) 7½ hours starting at 2200 hours on Monday 22nd November 2010 or on any subsequent day other than a Friday, Saturday or Sunday,
- (ii) 7 hours starting at 2230 hours on Friday 26th November 2010 or on any subsequent Friday,
- (iii) 8 hours starting at 2200 hours on Saturday 27th November 2010 or on any subsequent Saturday, or
- (iv) 7 hours starting at 2230 hours on Sunday 28th November 2010 or on any subsequent Sunday,

until 19th May 2012.

**3.** Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in the slip road.

**4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to –

- (a) a vehicle being used in connection with the said works;
- (b) a vehicle being used for police, ambulance, fire and rescue authority or traffic officer purposes;
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
- (d) any vehicle being used for winter maintenance purposes.
