## ROAD TRAFFIC

## The A13 Trunk Road (Near Grays) (Temporary 50 Miles Per Hour Speed Restriction) Order 2011

 Made
 25th July 2011

 Coming into force
 13th August 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A13 Trunk Road, is satisfied that traffic should be restricted on lengths of that road because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

**1.** This Order may be cited as the A13 Trunk Road (Near Grays) (Temporary 50 Miles Per Hour Speed Restriction) Order 2011 and shall come into force on 13th August 2011.

## 2. In this Order:

"the trunk road" means the A13 Trunk Road near Grays in the Borough of Thurrock;

"a length of carriageway" means -

- (i) the eastbound carriageway of the trunk road between points 2400 metres west and 800 metres east of Stifford Clays Road underbridge east of North Stifford,
- (ii) the westbound carriageway of the trunk road between points 2500 metres east and 700 metres west of Stifford Clays Road underbridge east of North Stifford,
- (iii) the eastbound carriageway of the trunk road between points 2500 metres west and 650 metres east of the A1089 underbridge near Baker Street, or
- (iv) the westbound carriageway of the trunk road between points 2350 metres east and 800 metres west of the A1089 underbridge near Baker Street;

"works" mean resurfacing, bridge expansion joint repairs and white lining work on the trunk road; and

"a works period" means a period of -

- (i) 7½ hours starting at 2200 hours on Monday 15th August 2011 or on any subsequent day other than a Friday, Saturday or Sunday,
- (ii) 7 hours starting at 2300 hours on Friday 19th August 2011 or on any subsequent Friday,
- (iii) 8 hours starting at 2200 hours on Saturday 20th August 2011 or on any subsequent Saturday, or

(iv) 7 hours starting at 2230 hours on Sunday 21st August 2011 or on any subsequent Sunday,

until 12th February 2013.

- **3.** Subject as mentioned in article 4 below, no person shall, during a works period, drive any motor vehicle at a speed exceeding 50 miles per hour on a length of carriageway.
- **4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to a vehicle being used for police, ambulance or fire and rescue authority purposes and to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(**a**) when used in accordance with regulation 3(5) of those Regulations.
