**The Nuffield Orthopaedic Centre National Health Service Trust  
(Transfer of Trust Property) Order 2011**

The Secretary of State for Health makes the following Order in exercise of the powers conferred by sections 213, 217(2) and 272(7) and (8) of the National Health Service Act 2006(a), having regard to changes in the functions of the Oxford University Hospitals National Health Service Trust(b).

**Citation, commencement and interpretation**

1.—(1) This Order may be cited as the Nuffield Orthopaedic Centre National Health Service Trust (Transfer of Trust Property) Order 2011 and shall come into force on 1st November 2011.

(2) In this Order—

“the trustees” means the trustees for the Oxford University Hospitals National Health Service Trust(c);

“the old Trust” means the Nuffield Orthopaedic Centre National Health Service Trust(d);

“the trust property” means the property specified in the schedule of trust property prepared and agreed by the old Trust and the trustees and signed on behalf of the old Trust and on behalf of the trustees on 9th September 2011(e).

**Transfer of trust property**

2.—(1) On the date that this Order comes into force the trust property, and any rights and liabilities arising from that property, shall be transferred from the old Trust to the trustees.

(2) In any instrument relating to the trust property, any reference to the trustees of the trust property or to the old Trust shall be construed as a reference to the trustees.
