ROAD TRAFFIC

The M3 Motorway (Junctions 3 – 13, Slip Roads) (Temporary Prohibition of Traffic) Order 2012

 Made
 10th April 2012

 Coming into force
 28th April 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the M3 Motorway and connecting roads, is satisfied that traffic should be prohibited on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the M3 Motorway (Junctions 3 - 13, Slip Roads) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 28th April 2012.

2. In this Order:

"the motorway" means the M3 Motorway in the Counties of Surrey and Hampshire;

"a slip road" means –

- (a) at Junction 3 near Camberley
 - (i) the road leading to the eastbound carriageway of the motorway from the A322, or
 - (ii) the road leading to the westbound carriageway of the motorway from the A322;
- (b) at Junction 4 near Frimley
 - (i) the road leading to the eastbound carriageway of the motorway from the A331,
 - (ii) the road leading from the eastbound carriageway of the motorway to the A331, or
 - (iii) the road leading to the westbound carriageway of the motorway from the A331;
- (c) at Junction 4A near Farnborough
 - (i) the road leading from the eastbound carriageway of the motorway to the A327 (Minley Road),
 - (ii) the road leading to the eastbound carriageway of the motorway from the A327 (Minley Road),

- (iii) the road leading from the westbound carriageway of the motorway to the A327 (Minley Road), or
- (iv) the road leading to the westbound carriageway of the motorway from the A327 (Minley Road);

(d) at Junction 5 near Hook –

- (i) the road leading from the eastbound carriageway of the motorway to the A287/B3349,
- (ii) the road leading to the eastbound carriageway of the motorway from the A287/B3349,
- (iii) the road leading from the westbound carriageway of the motorway to the A287/B3349, or
- (iv) the road leading to the westbound carriageway of the motorway from the A287/B3349;

(e) at Junction 7 near Basingstoke –

- (i) the road leading from the eastbound carriageway of the motorway to the A30.
- (ii) the road leading to the eastbound carriageway of the motorway from the A30,
- (iii) the road leading from the westbound carriageway of the motorway to the A30, or
- (iv) the road leading to the westbound carriageway of the motorway from the A30;

(f) at Winchester Services –

- (i) the roads leading to and from the northbound carriageway of the motorway, or
- (ii) the roads leading to and from the southbound carriageway of the motorway;

(g) at Junction 10 near Winchester –

- (i) the road leading from the northbound carriageway of the motorway to the A31/B3330, or
- (ii) the road leading to the southbound carriageway of the motorway from the A31;

(h) at Junction 11 near Twyford –

- (i) the road leading from the northbound carriageway of the motorway to the A3090 (Hockley Link),
- (ii) the road leading to the northbound carriageway of the motorway from the A3090 (Hockley Link),
- (iii) the road leading from the southbound carriageway of the motorway to the A3090 (Hockley Link)/B3335, or
- (iv) the road leading to the southbound carriageway of the motorway from the A3090 (Hockley Link);

(i) at Junction 12 near Eastleigh –

- (i) the road leading from the northbound carriageway of the motorway to the A335 (Allbrook Way),
- (ii) the road leading to the northbound carriageway of the motorway from the A335 (Allbrook Way),
- (iii) the road leading from the southbound carriageway of the motorway to the A335 (Allbrook Way), or
- (iv) the road leading to the southbound carriageway of the motorway from the A335 (Allbrook Way);

- (j) at Junction 13 at Eastleigh
 - (i) the road leading from the northbound carriageway of the motorway to the A335,
 - (ii) the road leading to the northbound carriageway of the motorway from the A335, or
 - (iii) the road leading from the southbound carriageway of the motorway to the A335 (Leigh Road);

"works" mean road marking, essential carriageway repairs and all associated works on the motorway; and

- "a works period" means a period of 8 hours starting at 2200 hours on Monday 30th April 2012 or on any subsequent day until 27th October 2013.
- **3.** Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in a slip road.
- **4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -
 - (a) a vehicle being used in connection with the said works;
 - (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
 - (d) any vehicle being used for winter maintenance purposes.
