ROAD TRAFFIC

**The A483 Trunk Road (South East of Oswestry, Shropshire)
(Temporary Restriction and Prohibition of Traffic) Order 2012**

Made - - - - - *31st December 2012*
Coming into force - - - *7th January 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A483 Trunk Road (“the A483”), is satisfied that traffic on a length of that road south east of Oswestry in the County of Shropshire, should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A483 Trunk Road (South East of Oswestry, Shropshire) (Temporary Restriction and Prohibition of Traffic) Order 2012 and shall come into force on 7th January 2013.

2. In this Order –

“the trunk road” means the A483 between its roundabout junction with the A5 and the B4579 (Mile End Roundabout) and its junction with the B5069;

“layby” means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(b) and partly by the outer edge of that carriageway on the same side of the road as that on which the marking is placed; and in this definition “carriageway” means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;

“the works period”

means the period starting at 20.00 hours on Monday 14th January 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 6 and 7, no person shall, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the trunk road.

4. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the trunk road.

5. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed in any layby adjacent to the trunk road.

6. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

7. The provisions of –

(a) articles 3, 4 and 5 shall not apply to any vehicle -

(i) being used for police, fire brigade or ambulance purposes; and

(ii) proceeding at the direction of, or with the permission of, a police constable;

(b) article 3 shall not apply to any vehicle being used for special forces purposes;

(c) articles 4 and 5 shall not apply to any vehicle being used in connection with the said works; and

(d) article 4 shall not apply to any vehicle proceeding in the trunk road to or from premises which is accessible for that vehicle from, and only from, that road.
