ROAD TRAFFIC

The M6 Motorway (Junctions 4 to 2) (Temporary Prohibition of Traffic) Order 2012

Made - - - - - 17th February 2012
Coming into force - - 24th February 2012

WHEREAS the Secretary of State for Transport, being the traffic authority for the M6 Motorway (“the M6”) and connecting roads, is satisfied that traffic on a length of that motorway and on some of those connecting roads, in the County of Warwickshire and the City of Coventry, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling her in that behalf, hereby makes the following Order: -

1. This Order may be cited as the M6 Motorway (Junctions 4 to 2) (Temporary Prohibition of Traffic) Order 2012 and shall come into force on 24th February 2012.

2. In this Order:

| “the motorway” | means the southbound carriageway of the M6 from its junction with the exit slip road at Junction 4 to its junction with the entry slip road at Junction 2; |
| “a link road” | means –
i) the link road leading from the northbound carriageway of the M42 at Junction 7a to the southbound carriageway of the M6; and
ii) the link road from the southbound carriageway of the M6 Toll Road to the southbound carriageway of the M6; |
| “a slip road” | means –
i) the slip road leading to the southbound carriageway of the M6 at Junction 4;
ii) the slip road leading to the southbound carriageway of the M6 at Junction 3; and
iii) the slip leading from Corley Motorway Service Area to the southbound carriageway of the M6. |

“the works period”

means the period starting at 20:00 hours on Wednesday 29th February 2012 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the motorway, a link road or a slip road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle –

- (i) being used for police, fire brigade or ambulance purposes;
- (ii) proceeding at the direction of, or with the permission of, a police constable, or traffic officer in uniform, or
- (iii) being used in connection with the said works or by a traffic officer in uniform.
