**ROAD TRAFFIC**

**The M50 Motorway (Junctions 4 to 2) (Temporary Prohibition  
of Traffic) Order 2013**

*Made - - - - 15th April 2013*

*Coming into force - - 22nd April 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the M50 Motorway (“the M50”) and connecting roads, is satisfied that traffic on lengths of that motorway and on five of those connecting roads, between Junctions 4 and 2 in the District of the County of Herefordshire and the County of Gloucestershire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the M50 Motorway (Junctions 4 to 2) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 22nd April 2013.

2. In this Order:

“the motorway” means –

- i) the eastbound carriageway of the M50 from its roundabout junction with the A40, A449 and B4221 at Junction 4 to its junction with the entry slip road at Junction 2; and
- ii) the westbound carriageway of the M50 from its junction with exit slip road at Junction 2 to its roundabout junction with the A40, A449 and B4221 at Junction 4;

“a slip road” means the slip roads leading –

- i) to and from the eastbound carriageway of the M50 at Junction 3;
- ii) to the westbound carriageway of the M50 at Junction 2; and
- iii) to and from the westbound carriageway of the M50 at Junction 3;

“the works period” means the period starting at 20.00 hours on Monday 29th April 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the motorway or a slip road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle –

- (i) being used for police, fire brigade or ambulance purposes;
- (ii) proceeding at the direction of, or with the permission of, a police constable, or traffic officer in uniform; or
- (iii) being used in connection with the said works or by a traffic officer in uniform.
