**ROAD TRAFFIC**

**The M42 Motorway and A42 Trunk Road (Measham,  
Leicestershire) (Temporary Prohibition of Traffic) Order 2013**

*Made* - - - - - *8th July 2013*  
*Coming into force* - - - - - *15th July 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the M42 Motorway (“the M42”), the A42 Trunk Road (“the A42”) and connecting roads, is satisfied that traffic on lengths of those roads and four of those connecting roads near Measham in the County of Leicestershire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984 (a), hereby makes the following Order:-

1. This Order may be cited as The M42 Motorway and A42 Trunk Road (Measham, Leicestershire) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 15th July 2013.

2. In this Order:

- “the motorway” means –
- i) the northbound carriageway of the M42 from its junction with the exit slip road at Junction 11 to its junction with the A42; and
  - ii) the southbound carriageway of the M42 from its junction with A42 to its junction with the entry slip road at Junction 11;
- “the trunk road” means -
- i) the northbound carriageway of the A42 from its junction with the M42 at Junction 11 to its junction with the slip road leading from the roundabout junction with the A5006, Measham Road; and

- ii) the southbound carriageway of the A42 from its junction with the slip road leading to the roundabout junction with the B4116, Measham Road to its junction with the M42;

“a slip road”

means the slip road leading –

- i) to the northbound carriageway of the A42 at M42 Junction 11;
- ii) from the northbound carriageway of the A42 to the roundabout junction with A5006, Measham Road (Junction 12);
- iii) to the southbound carriageway of the A42 from its roundabout junction with the B4116, Measham Road (Junction 12); and
- iv) from the southbound carriageway of the A42 at M42 Junction 11;

“layby”

means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(a) and partly by the outer edge of that carriageway on the same side of the road as that on which the marking is placed; and in this definition “carriageway” means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a suitable surface for the exercise of that right;

“the works period”

means the period starting at 21.00 hours on Sunday 21st July 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the motorway, the trunk road or a slip road.

**4.** Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the layby adjacent to the trunk road approximately –

- i) 173 metres south of the centreline of the River Mease Bridge;
- ii) 957 metres north of the centreline of the New Street overbridge; and
- iii) 709 metres south of the centreline of the Willesley Woodside overbridge.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle –

- (i) being used for police, fire brigade or ambulance purposes;
- (ii) proceeding at the direction of, or with the permission of, a police constable; or
- (iii) being used in connection with the said works.
