**The Civil Enforcement of Parking  
Contraventions Designation Order 2013**

This Order is made in exercise of powers conferred by—

- (a) section 89(3) of the Traffic Management Act 2004<sup>(1)</sup> (“the 2004 Act”);
- (b) paragraph 8(1) of Schedule 8 to the 2004 Act;
- (c) paragraph 3(1) of Schedule 10 to the 2004 Act; and
- (d) section 144(3)(b) of the Transport Act 2000<sup>(2)</sup>.

The Worcestershire County Council has applied to the Secretary of State for an order to be made, in exercise of those powers, in respect of part of that council’s area.

The Council of the City of Newcastle upon Tyne has applied to the Secretary of State for an order to be made, in exercise of those powers, in respect of part of that council’s area.

Cheshire West and Chester Borough Council<sup>(3)</sup> has applied to the Secretary of State for an order to be made, in exercise of those powers, in respect of part of that council’s area.

In accordance with the requirements of paragraph 8(3) of Schedule 8, and paragraph 3(4) of Schedule 10, to the 2004 Act, the Secretary of State has consulted the chief officers of police of West Mercia Police, Northumbria Police and Cheshire Constabulary.

Accordingly, the Secretary of State<sup>(4)</sup> makes this Order.

The powers conferred by section 144 are conferred on “the relevant national authority”. By virtue of section 144(14), the Secretary of State is the “relevant national authority”, as respects England.  
(3) By the Cheshire (Structural Changes) Order 2008 ([S.I. 2008/634](#)), the county of Cheshire was abolished and its county council wound up and dissolved (article 5). That order established a new non-metropolitan county and a new non-metropolitan district, each to be known as Cheshire West and Chester (article 4(1)).  
(4) The Secretary of State is, by virtue of section 92 of the Traffic Management Act 2004, the ‘appropriate national authority’ as regards England for the purposes of Part 6 of that Act.

### **Citation and commencement**

1.—(1) This Order may be cited as the Civil Enforcement of Parking Contraventions Designation Order 2013.

(2) Articles 1, 3 and 4 of this Order come into force on 12th November 2013.

(3) Articles 2, 5 and 6 come into force on 20th November 2013.

### **Revocation of previous orders**

2. The Civil Enforcement of Parking Contraventions (County of Cheshire) (City of Chester and Borough of Ellesmere Port & Neston) Designation Order 2008<sup>(5)</sup> is revoked.

### **Amendment of the Civil Enforcement of Parking Contraventions (City of Newcastle upon Tyne) Designation Order 2009**

3.—(1) The Civil Enforcement of Parking Contraventions (City of Newcastle upon Tyne) Designation Order 2009<sup>(6)</sup> is amended as follows.

(2) Omit paragraphs (a), (b), (c) and (d) of the Schedule.

### **Designation of civil enforcement areas and special enforcement areas under the Traffic Management Act 2004**

4. The Secretary of State designates the part of the area of The Worcestershire County Council specified in Schedule 1 as—

- (a) a civil enforcement area for parking contraventions; and
- (b) a special enforcement area.

5. The Secretary of State designates the part of the area of Cheshire West and Chester Borough Council specified in Schedule 2 as—

- (a) a civil enforcement area for parking contraventions; and
- (b) a special enforcement area.

### **Amendment of the Bus Lane Contraventions (Approved Local Authorities) (England) Order 2005**

6.—(1) The Bus Lane Contraventions (Approved Local Authorities) (England) Order 2005<sup>(7)</sup> is amended as follows.

(2) In the table in Schedule 2, in the row relating to the Cheshire West and Chester Borough Council, in column 2 for “2008/3198” substitute “2013/2594”.

The whole of the area of The Malvern Hills District Council except—

  - (ii) Ordnance Survey national grid reference point SJ7431566682 to Ordnance Survey national grid reference point SJ7494165736;
- (q) The M53 for its entire length within the area from Ordnance Survey national grid reference point SJ3684278908 to Ordnance Survey national grid reference point SJ4346668427, including its slip roads; and
- (r) The M56 for its entire length within the area, including its slip roads, from—
- (i) Ordnance Survey national grid reference point SJ3706772112 to Ordnance Survey national grid reference point SJ5290079430; and
  - (ii) Ordnance Survey national grid reference point SJ5413079739 to Ordnance Survey national grid reference point SJ5543779710.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order designates the area of the Malvern Hills District Council, with the exception of the roads referred to in Schedule 1, as a civil enforcement area for parking contraventions and as a special enforcement area for the purposes of Part 6 of the Traffic Management Act 2004.

This Order also amends the Civil Enforcement of Parking Contraventions (City of Newcastle upon Tyne) Designation Order 2009 (S.I. 2009/596, “the 2009 Order”) so as to permit civil enforcement on some of the roads that were previously excluded.

This Order simultaneously revokes the Civil Enforcement of Parking Contraventions (County of Cheshire) (City of Chester and Borough of Ellesmere Port & Neston) Designation Order 2008 (S.I. 2008/3198, “the 2008 Order”) made under the Traffic Management Act 2004. This Order then re-designates the area previously designated by the 2008 Order alongside a further area so as to designate the whole of the area of Cheshire West and Chester Borough Council with the exception of the roads referred to at Schedule 2.

This Order also makes a consequential amendment to the Bus Lane Contraventions (Approved Local Authorities) (England) Order 2005 (S.I. 2005/2755).
