**ROAD TRAFFIC**

**The A14 Trunk Road (Junction 54 Sproughton to Junction 52  
Claydon, Suffolk) Westbound (Temporary Restriction and  
Prohibition of Traffic) Order 2013**

*Made* - - - - *21st October 2013*

*Coming into force* - - *28th October 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A14 Trunk Road (“the A14”) is satisfied that traffic on lengths of that road in the County of Suffolk, should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A14 Trunk Road (Junction 54 Sproughton to Junction 52 Claydon, Suffolk) Westbound (Temporary Restriction and Prohibition of Traffic) Order 2013 and shall come into force on 28th October 2013.

2. In this Order –

“tip of the nosing” means, as indicated by the markings on the carriageway, the first point where an entry slip road joins, or the last point where an exit slip road leaves, the carriageway of the trunk road;

“the first length of trunk road” means the westbound carriageway of the A14 from the tip of the nosing of the entry slip road at Junction 54 Sproughton Interchange to the tip of the nosing of the entry slip road at Junction 52 Claydon Interchange;

“the second length of trunk road” means the westbound carriageway of the A14 between the tips of the nosings of the exit and entry slip roads at Junction 52 Claydon Interchange;

“works” mean carriageway resurfacing and replacement of road markings;

“a works period” means a period of –

- (a) 15 hours starting at 19.00 hours on Friday 1st November 2013 or on any subsequent Friday,
- (b) 37 hours starting at 18.00 hours on Saturday 2nd November 2013 or on any subsequent Saturday, or
- (c) 12 hours starting at 19.00 hours on Monday 4th November 2013 or on any subsequent Monday,

until the works have been completed;

---

“the works period” means the period starting at 19.00 hours on Friday 1st November 2013 and ending when the works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in articles 5 and 6 no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour on the first length of trunk road.

**4.** Subject as mentioned in articles 5 and 6 no person shall, during a works period, cause or permit any vehicle to enter or proceed in the second length of trunk road.

**5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs.

- 6.** The provisions of article 4 shall not apply to a vehicle –
- (a) being used in connection with the works,
  - (b) being used for police, fire and rescue authority or ambulance purposes, or
  - (c) proceeding at the direction, or with the permission, of a constable;

and nothing in article 3 shall apply to a vehicle being used for a purpose specified in paragraph (b) of this article or to a vehicle falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011<sup>(a)</sup> when used in accordance with regulation 3(5) of those Regulations.
