ROAD TRAFFIC

The A38 Trunk Road (Glynn Valley, Near Bodmin) (Temporary Restriction and Prohibition of Traffic) (Number 2) Order 2013

Made - - - - 27th November 2013

Coming into force - - 30th November 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A38 Trunk Road ("the A38"), is satisfied that traffic on lengths of that road between Turfdown Roundabout and Twelve Woods Roundabout near Bodmin in Cornwall should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A38 Trunk Road (Glynn Valley, Near Bodmin) (Temporary Restriction and Prohibition of Traffic) (Number 2) Order 2013 and shall come into force on 30th November 2013.

2. In this Order -

"the first length of the A38" means the A38 from the eastern edge of Turfdown Roundabout to the centre of its junction with Bodmin Parkway Station;

"the second length of the A38" means the A38 from the eastern edge of Turfdown Roundabout, Bodmin, to the western edge of Twelve Woods Roundabout (junction with the A390):

"the works" mean drainage upgrades and routine maintenance works;

"bicycle" means a pedal cycle with fewer than four wheels and not being a mechanically propelled vehicle;

"the local roads" mean all the side roads leading to and from the second length of the A38;

"the works period" means the period starting at 00.01 hours on Monday 2nd December 2013 and ending when the said works have been completed;

"a first works period" means a period of 11 hours starting at 19.00 hours on Wednesday 1st January 2014 or on any subsequent Wednesday, Thursday, Monday or Tuesday and ending when the said works have been completed;

"a second works period" means a period of 13 hours starting at 19.00 hours on Friday 3rd January 2014 or on any subsequent Friday and ending when the said works have been completed;

"a third works period" means a period of 14 hours starting at 19.00 hours on Saturday 4th January 2014 or on any subsequent Saturday and ending when the said works have been completed;

"a fourth works period" means a period of 12 hours starting at 18.00 hours on Sunday 5th January 2014 or on any subsequent Sunday and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 7 and 9, no person shall, during the works period, drive any motor vehicle at a speed exceeding 30 miles per hour on the first length of the A38.
- **4.** Subject as mentioned in articles 7 and 8, no person shall, during a first works period, a second works period, a third works period or a fourth works period, cause or permit any vehicle to enter or proceed in the second length of the A38.
- **5.** Subject as mentioned in articles 7 and 8, no person using a bicycle shall enter or proceed in the second length of the A38 during a first works period, a second works period, a third works period or a fourth works period.
- **6.** Subject as mentioned in articles 7 and 8, no person shall, during a first works period, a second works period, a third works period or a fourth works period, cause or permit any vehicle to enter or leave the A38 at its junctions with the local roads.
- 7. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) anything done at the direction of, or with the permission of, a constable;
 - (c) a vehicle being used in connection with the said works.
 - **8**. The provisions of articles 4, 5 and 6 shall not apply to:
 - (a) a vehicle being used in connection with the said works or for winter maintenance purposes;
 - (b) a vehicle being used for traffic officer purposes;
 - (c) a vehicle proceeding to or from premises that are accessible from and only from the A38.
- **9**. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
