**The A631 Trunk Road (Tinsley Viaduct) (Temporary Restriction
and Prohibition of Traffic) Order 2013**

Made - - - - 14th February 2013

Coming into force - - 24th February 2013

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A631 Trunk Road, in the District of Sheffield, in the County of South Yorkshire, is satisfied that traffic on that trunk road should be restricted and prohibited because weather monitoring equipment installation works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

1. This Order may be cited as the A631 Trunk Road (Tinsley Viaduct) (Temporary Restriction and Prohibition of Traffic) Order 2013 and shall come into force on 24th February 2013.

2. In this Order; –

“the A631” means the A631 Trunk Road, Tinsley Viaduct lower deck, northbound carriageway between its junction with the southern and northern roundabouts at either end of the viaduct, a distance of 1000 metres;

“the works period” means a period of 10 hours starting at 20:00 hours on Monday 25th February 2013 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 30 miles per hour in the A631.

4. Subject as mentioned in article 5 no person shall, during the works period, cause or permit any traffic to enter or proceed in the A631.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs. Nothing in article 4 shall apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
- (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in article 3 shall apply to a vehicle being used for the purpose specified in paragraph (a) of this article.

6. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
