**ROAD TRAFFIC**

**The M6 Motorway (Junctions 44-45 Southbound Carriageway)  
(Temporary Restriction of Traffic) Order 2014**

*Made* - - - - - *24th April 2014*

*Coming into force* - - - - - *26th April 2014*

WHEREAS the Secretary of State for Transport being the traffic authority for the M6 Motorway is satisfied that traffic on a section of that motorway in the District of Carlisle in the County of Cumbria, should be restricted because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the M6 Motorway (Junctions 44-45 Southbound Carriageway) (Temporary Restriction of Traffic) Order 2014 and shall come into force on 26th April 2014.
2. In this Order:
  - “the motorway” means the M6 Motorway;
  - “the length of carriageway” means the southbound carriageway of the motorway from a point 360 metres north of the centreline of the River Esk overbridge to a point 2200 metres south of the centreline of the River Esk overbridge;
  - “works” means vehicle restraint system works on the motorway;
  - “the works period” means a period starting at 2000 hours on Sunday 27 April 2014 and ending at 2200 hours on Friday 9 May 2014. However, work may start and continue beyond these dates for such period not exceeding 18 months as shall be required to complete the work.
3. Subject as mentioned in articles 4 and 5 of this Order, during the works period, no person shall cause or permit any vehicle to be driven in the length of carriageway at a speed exceeding 50 miles per hour.
4. The provisions of article 3 of this Order shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to a vehicle being used for emergency purposes by the police, fire and rescue authority or ambulance services or anything done at the direction, or with the permission, of a constable, or a traffic officer in uniform.

5. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 (a) when used in accordance with regulation 3(5) of those Regulations.
