### **ROAD TRAFFIC**

# The A1 Trunk Road and A1(M) Motorway (Barnet By-Pass) (Temporary Prohibition of Traffic) Order 2014

 Made
 17th March 2014

 Coming into force
 5th April 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A1 Trunk Road and A1(M) Motorway and connecting roads, is satisfied that traffic should be prohibited on lengths of that motorway and on some of those connecting road because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

**1.** This Order may be cited as the A1 Trunk Road and A1(M) Motorway (Barnet By-Pass) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 5th April 2014.

#### 2. In this Order:

"the trunk road" means the A1 Trunk Road in the County of Hertfordshire;

"the motorway" means the A1(M) Motorway in the County of Hertfordshire;

"the length of carriageway" means the northbound carriageway of the trunk road and motorway between the southbound bridge at Rowley Lane roundabout (A5135) and the "on" slip road at Junction 1 of the motorway (M25 Junction 23);

"the slip road means the road leading from the A5135 (Elstree Way) to the northbound carriageway of the trunk road at Rowley Lane roundabout;

"works" mean essential power cable line repairs, carriageway repairs and all other associated work on the motorway;

"the side road" means Holmshill Lane at its junction with the northbound carriageway of the trunk road; and

"a works period" means a period of -

- (i) 7½ hours starting at 2200 hours on Monday 7th April 2014 or on any subsequent day other than a Friday, Saturday or Sunday,
- (ii) 7 hours starting at 2300 hours on Friday 11th April 2014 or on any subsequent Friday,
- (iii) 8 hours starting at 2200 hours on Saturday 12th April 2014 or on any subsequent Saturday, or

(iv) 7 hours starting at 2230 hours on Sunday 13th April 2014 or on any subsequent Sunday

until 4th October 2015.

- **3.** Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in a length of carriageway, the side road or the slip road.
- **4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -
  - (a) a vehicle being used in connection with the said works;
  - (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;
  - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
  - (d) any vehicle being used for winter maintenance purposes.
