The Air Navigation (Restriction of Flying) (Jet Formation Display Teams) (No. 4) Regulations 2014

Made - - - - 5th June 2014

Coming into force - - 8th August 2014

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the vicinity of the places specified in column 1 of the Schedule by reason of flying displays to be held there by jet formation display teams on various days between the 8th August and 21st September 2014.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order 2009(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Jet Formation Display Teams) (No. 4) Regulations 2014 and come into force on 8th August 2014.

Interpretation

2. In regulation 3 all times referred to are Co-ordinated Universal Time(**b**).

Restricted airspace

- **3.**—(1) Subject to paragraph (2), during the period commencing at 1000 hours and ending at 2000 hours, at each of the places specified in column 1 and on the corresponding date specified in column 4 of the Schedule, no aircraft is to fly—
 - (a) in the airspace above the area bounded by a circle having a radius of 6 nautical miles, the centre of which is at the corresponding point specified in column 2 of the Schedule, and
 - (b) below the corresponding altitude specified in column 3 of the Schedule.
 - (2) Paragraph (1) does not apply to any aircraft—
 - (a) flying within controlled airspace if it flies in accordance with an air traffic control clearance issued by the appropriate air traffic control unit; or
 - (b) flying within the aerodrome traffic zone of an aerodrome having an air traffic control unit if it flies in accordance with a permission issued by that unit.

⁽b) Co-ordinated Universal Time (UTC) is one hour behind British Summer Time (BST).

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in the locations and airspace specified in the Schedule during flying displays by the Royal Air Force Aerobatic Team, the Red Arrows, and possibly other jet formation aerobatic display teams, which are due to take place during the period 8th August and 21st September 2014.

In order to protect the display aircraft, other air traffic and spectators, it is considered that flying should be restricted in the vicinity of the airspace within which the display teams will perform. The Regulations contain details of the locations and areas of the displays. Details will also be published by AIC and NOTAM.

Periods between 1000 and 2000 hours on each particular day falling outside the actual display times will be subject to an exemption applying to all other aircraft complying with local air traffic control permission. This has been agreed with the Department for Transport.

The times mentioned in this instrument are Universal Co-ordinated Time (UTC), which is one hour behind British Summer Time.
