**The Air Navigation (Restriction of Flying) (Ascot) Regulations  
2014**

*Made* - - - - *12th June 2014*

*Coming into force* - - *14th August 2014*

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the vicinity of Ascot, Berkshire, by reason of the Red Bull Air Race that is scheduled to take place there during the period from 14th to 17th August 2014.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order 2009<sup>(a)</sup>.

**Citation and commencement**

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Ascot) Regulations 2014 and come into force on 14th August 2014.

**Interpretation**

2. In regulation 3(1) all times referred to are Co-ordinated Universal Time<sup>(b)</sup>.

**Restricted airspace**

3.—(1) Subject to paragraph (3)—

- (a) between 0800 hours and 1800 hours on 14th August 2014,
- (b) between 0900 hours and 1700 hours on 15th August 2014,
- (c) between 0800 hours and 1830 hours on 16th August 2014, and
- (d) between 1100 hours and 1730 hours on 17th August 2014,

no aircraft is to fly below 1,500 feet above mean sea level within the area described in paragraph (2).

(2) The area mentioned in paragraph (1) is bounded successively by—

- (a) the clockwise arc of a circle having a radius 1.5 nautical miles, centred on 512502N 0004117W, between the points 512332N 0004116W and 512632N 0004119W,
- (b) a straight line joining the points—
  - (i) 512632N 0004119W, and

- (ii) 512632N 0003552W,
- (c) the clockwise arc of a circle having a radius 1.5 nautical miles, centred on 512504N 0003551W, between the points 512634N 0003552W and 512334N 0003549W, and
- (d) a straight line joining the points—
  - (i) 512334N 0003549W, and
  - (ii) 512332N 0004116W.

(3) Paragraph (1) does not apply to any aircraft flying with the permission of the Red Bull Air Race flying display director.

#### **EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations impose restrictions on flying in airspace in the vicinity of the Racecourse at Ascot, Berkshire, during the Red Bull Air Race that is scheduled to take place there in the period from 14th to 17th August 2014.

A temporary restriction on flying has been proposed by the Civil Aviation Authority in the vicinity of Ascot for reasons of public safety and to protect the Race participants. This has been agreed with the Department for Transport.

The times mentioned in regulation 3(1) are Universal Co-ordinated Time (UTC), which is one hour behind British Summer Time.

In relation to the permission mentioned in regulation 3(3), the Red Bull Air Race flying display director may be contacted on telephone number 07711 437499.

Full details of the Statutory Instrument will be promulgated by Aeronautical Information Circular and NOTAM.
