**ROAD TRAFFIC**

**The A1 and A52 Trunk Roads (Barrowby, Lincolnshire) (Slip Road) (Temporary Prohibition of Traffic) Order 2014**

*Made* - - - - 20th January 2014

*Coming into force* - - 27th January 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A1 Trunk Road (“the A1”), the A52 Trunk Road (“the A52”) and connecting roads, is satisfied that traffic on four of those connecting roads at Barrowby, near Grantham in the County of Lincolnshire, should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A1 and A52 Trunk Roads (Barrowby, Lincolnshire) (Slip Road) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Monday 27th January 2014.

2. In this Order –

“the slip road”

means the slip road leading –

- (i) from the southbound carriageway of the A1 to its junction with the A52; and
- (ii) from the A52 to the southbound carriageway of the A1; and
- (iii) from the northbound carriageway of the A1 to its junction with the A52; and
- (iv) from the A52 to the northbound carriageway of the A1.

"the works period"

means the period starting at 20:00 hours on Monday 3rd February 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed in any of the slip roads of the A1 with its junction of the A52.

4. Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed in any layby adjacent to the A1 between its junction with the A52 and its junction with the A607 (Harlaxton Road).

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

6. The provisions of articles 3 and 4 shall not apply to any vehicle -

- (i) being used for police, fire brigade or ambulance purposes; or
- (ii) proceeding at the direction of, or with the permission of, a police constable; and
- (iii) being used in connection with the said works.
