**ROAD TRAFFIC**

**The A27 Trunk Road (Portfield Roundabout – Whyke Roundabout) (Temporary Restriction of Traffic) Order 2014**

*Made* - - - - *14th July 2014*  
*Coming into force* - - *3rd August 2014*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A27 Trunk Road, is satisfied that traffic should be restricted and prohibited on lengths of that road because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) and paragraph 27(1) of schedule 9 to, the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

**1.** This Order may be cited as the A27 Trunk Road (Portfield Roundabout – Whyke Roundabout) (Temporary Restriction of Traffic) Order 2014 and shall come into force on 3rd August 2014.

**2.** In this Order:

“the trunk road” means the A27 Trunk Road near Chichester in the County of West Sussex;

“the first length of trunk road” means the eastbound carriageway of the trunk road between Whyke Roundabout (B2145) and a point 100 metres north of Bognor Road Roundabout (A259);

“the second length of trunk road” means the southbound carriageway of the trunk road between Portfield Roundabout (A285) and a point 300 metres south of Bognor Road Roundabout (A259);

“works” mean carriageway widening, surfacing, drainage, lighting, barrier works and all associated works; and

“the works period” means the period starting on Tuesday 5th August 2014 and ending on 4th February 2015.

**3.** Subject as mentioned in articles 4 and 5 below, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the first length of trunk road or second length of trunk road.

**4.** The provisions of articles 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs.

**5.** Nothing in article 3 above shall apply to a vehicle being used for police, ambulance or fire and rescue authority purposes and to vehicles falling within regulation 3(4) of the Road Traffic

7. The A27 Trunk Road (Portfield Roundabout – Bognor Road Roundabout) (Temporary Restriction and Prohibition of Traffic) Order 2014(b) is hereby revoked.
