ROAD TRAFFIC

The A27 Trunk Road (Portsbridge Roundabout – Eastern Road Interchange) (Temporary Prohibition of Traffic) Order 2014

 11th August 2014

 Coming into force
 30th August 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A27 Trunk Road and connecting roads, is satisfied that traffic should be prohibited on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A27 Trunk Road (Portsbridge Roundabout – Eastern Road Interchange) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 30th August 2014.

2. In this Order:

"the trunk road" means the A27 Trunk Road in the City of Portsmouth;

"a slip road" means –

- (i) the road leading to the eastbound carriageway of the trunk road at Portsbridge roundabout (A3/A27/A397),
- (ii) the road leading from the westbound carriageway of the trunk road at Portsbridge roundabout (A3/A27/A397),
- (iii) the road leading to the eastbound carriageway of the trunk road at Eastern Road Interchange (A2030),
- (iv) the road leading from the eastbound carriageway of the trunk road at Eastern Road Interchange (A2030),
- (v) the road leading to the westbound carriageway of the trunk road at Eastern Road Interchange (A2030), or
- (vi) the road leading from the westbound carriageway of the trunk road at Eastern Road Interchange (A2030);

"works" means essential carriageway repairs and all associated work on a slip road; and

"a works period" means a period of 8 hours starting at 2200 hours on Monday 1st September 2014 or on any subsequent day until 28th February 2016.

3. Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in a slip road.

- **4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -
 - (a) a vehicle being used in connection with the said works;
 - (b) a vehicle being used for police, ambulance, fire and rescue authority or traffic officer purposes;
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
 - (d) any vehicle being used for winter maintenance purposes.
