ROAD TRAFFIC

**The A1(M) Motorway (Junction 34 to Junction 38)
(Temporary Prohibition of Traffic) Order 2014**

Made - - - - *9th October 2014*

Coming into force - *19th October 2014*

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A1(M) Motorway, the A1 Trunk Road and connecting roads, in the Districts of Doncaster and Bassetlaw, in the Counties of South Yorkshire and Nottinghamshire, is satisfied that traffic on that motorway, that trunk road and some of those connecting roads should be prohibited because road stud renewal and road marking works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order:

1. This Order may be cited as the A1(M) Motorway (Junction 34 to Junction 38) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 19th October 2014.

2. Subject as mentioned in article 3 of this Order, no person shall, during a period of 10 hours starting at 20:00 hours on Monday 20th October 2014 or any subsequent night thereafter until the said works have been completed, cause or permit any vehicle to enter or proceed in the:

- (i) A1 Trunk Road southbound carriageway from the nose of the exit slip road at Junction 38 (Redhouse) to the nose of the entry slip road of the A1(M) Motorway southbound carriageway at Junction 34 (Blyth), a distance of 26110 metres;
- (ii) A1(M) Motorway northbound carriageway from the nose of the exit slip road at Junction 35 (Wadworth) to the nose of the entry slip road at Junction 38, a distance of 15310 metres;
- (iii) A1(M) Motorway southbound entry and northbound exit slip roads at Junction 38;
- (iv) A1(M) Motorway southbound and northbound entry and exit slip roads at Junction 37 (Marr);
- (v) A1(M) Motorway southbound and northbound entry and exit slip roads at Junction 36 (Warmsworth);
- (vi) A1(M) Motorway southbound entry and exit and northbound entry slip roads at Junction 35; or
- (vii) A1(M) Motorway southbound exit slip road at Junction 34.

3. The provisions of article 2 of this Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
- (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
