ROAD TRAFFIC

The M1 Motorway (Junction 47) (Temporary Restriction and Prohibition of Traffic) (No.2) Order 2014

Made - - - - 6th November 2014

Coming into force - 16th November 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the M1 Motorway and connecting roads, in the District of Leeds, in the County of West Yorkshire, is satisfied that traffic on that motorway and one of those connecting roads should be restricted and prohibited because loop cutting, carriageway resurfacing, white lining, road stud replacement, gully emptying, carriageway sweeping and general maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order:

1. This Order may be cited as the M1 Motorway (Junction 47) (Temporary Restriction and Prohibition of Traffic) (No.2) Order 2014 and shall come into force on 16th November 2014.

2. In this Order: -

“the M1” means the M1 Motorway;

“the carriageway” means the M1 northbound carriageway from a point 1000 metres south of the nose of the exit slip road at Junction 47 (Parlington) to the centre point of the northern bridge at Junction 47, a distance of 1600 metres;

“the slip road” means the M1 northbound exit slip road at Junction 47;

“the works period” means a period of 10 hours starting at 20:00 hours on Monday 17th November 2014 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour in the carriageway.

4. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the slip road.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs. Nothing in articles 4 shall apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1.

- (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in article 3 shall apply to a vehicle being used for the purposes specified in paragraph (a) of this article.

6. No speed limit imposed by this Order applies to vehicles falling within regulations 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011^(a) when used in accordance with regulation 3(5) of those Regulations.
