ROAD TRAFFIC

The A52 Trunk Road (Lenton Lane, Nottingham) (Temporary Prohibition of Traffic) Order 2014

Made - - - - *10th November 2014*
Coming into force - - *17th November 2014*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A52 Trunk Road (“the A52”) and connecting roads, is satisfied that traffic on two of those connecting roads, in the City of Nottingham, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A52 Trunk Road (Lenton Lane, Nottingham) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Monday 17th November 2014.

2. In this Order –

“a slip road” means the slip roads leading –
a) from the southbound carriageway of the A52 to Lenton Lane; and
b) to the southbound carriageway of the A52 from Lenton Lane, at Lenton Lane Industrial Estate East;

“bus stop area” means any area of a carriageway on a side of the trunk road, intended for the waiting of buses, which is comprised within and indicated by a road marking complying with diagram 1025, 1025.1, 1025.3 or 1025.4 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002;

"the works period" means the period starting at 20:00 hours on Monday 24th November 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in a slip road.

4. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the bus stop area adjacent to the southbound carriageway of the A52 situated 150 metres north of the slip road leading to Lenton Lane.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle –

- a) being used for police, fire brigade or ambulance purposes;
- b) proceeding at the direction of, or with the permission of, a police constable; or
- c) being used in connection with the said works.
