## ROAD TRAFFIC

The A449 Trunk Road and M50 Motorway (M50 Junctions 2 - 4) (Temporary Prohibition of Traffic) Order 2014

Made - - - - 21st November 2014

Coming into force - - 28th November 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A449 Trunk Road ("the A449"), the M50 Motorway ("the M50") and connecting roads, is satisfied that traffic on a length of those roads and some of those connecting roads, in the District of the County of Herefordshire and the County of Gloucestershire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A449 Trunk Road and M50 Motorway (M50 Junctions 2 - 4) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Friday 28th November 2014.

## 2. In this Order -

"Over Ross Roundabout" means the circulatory carriageway of the roundabout

junction of the A449 and the A40;

"Traveller's Rest Roundabout" means the circulatory carriageway of the roundabout

junction of the A449, the B4221 and M50 Junction 4;

"the trunk road" means –

(a) the eastbound carriageway of the A449 between Over Ross Roundabout and Traveller's Rest

Roundabout: and

(b) Traveller's Rest Roundabout:

"the motorway" means –

(a) the eastbound carriageway of the M50 from

Traveller's Rest Roundabout, to the junction with

the entry slip road at Junction 2; and

(b) the westbound carriageway of the M50 from the exit slip road at Junction 2, to Traveller's Rest Roundabout;

"a slip road"

means any slip roads leading to or from the motorway;

"the works period"

means the period starting at 20:00 hours on Monday 1st December 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the trunk road, the motorway or a slip road.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle
  - a. being used for police, fire brigade or ambulance purposes;
  - b.proceeding at the direction of, or with the permission of, a police constable or traffic officer in uniform;
  - c. being used in connection with the said works; or
  - d.proceeding to or from premises which are accessible from, and only from, the trunk road.
