**The M42 Motorway and A45 Trunk Road (M42 Junction 6,
Solihull) (Temporary Restriction and Prohibition of Traffic)
(No.2) Order 2014**

Made - - - - *21st November 2014*

Coming into force - - *28th November 2014*

WHEREAS the Secretary of State for Transport, being the traffic authority for the M42 Motorway (“the M42”) and A45 Trunk Road (“the A45”) and connecting roads, is satisfied that traffic on lengths of one of those roads, and some of those connecting roads in the Metropolitan Borough of Solihull should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a) hereby makes the following Order:-

1. This Order may be cited as the M42 Motorway and A45 Trunk Road (M42 Junction 6, Solihull) (Temporary Restriction and Prohibition of Traffic) (No.2) Order 2014 and shall come into force on Friday 28th November 2014.

2. In this Order:

“the trunk road” means the circulatory carriageway of the A45 at its junction with the M42 and South Way (M42 Junction 6);

“the first lengths of slip road” means the slip roads leading –
a) from the westbound carriageway of the A45 to its roundabout junction with the M42 and South Way (M42 Junction 6);
b) from the northbound carriageway of the M42 at Junction 6;
c) from the southbound carriageway of the M42 at Junction 6;

“the second lengths of slip road” means the slip roads leading –
a) from the northbound carriageway of the M42 at Junction 6;

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1

- b) from the southbound carriageway of the M42 at Junction 6;
- c) to the southbound carriageway of the M42 at Junction 6;
- d) from the westbound carriageway of the A45 to its roundabout junction with the M42 and South Way (M42 Junction 6);
- e) to the northbound carriageway of the M42 at Junction 6; and
- f) to the eastbound carriageway of the A45 from its roundabout junction with the M42 and South Way (M42 Junction 6);

“the link road” means the link road leading from the northbound carriageway of the M42 to the westbound carriageway of the A45;

"the works period" means the period starting at 00:01 hours on Monday 1st December 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 5 and 6, no person shall, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the trunk road, the first lengths of slip road or the link road.

4. Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road, the link road or the second lengths of slip road.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

6. The provisions of –

- a) article 3 shall not apply to any vehicle being used for special forces purposes;
- b) articles 3 and 4 shall not apply to any vehicle –
 - (i) being used for police, fire brigade or ambulance purposes; or
 - (ii) proceeding at the direction of, or with the permission of, a police constable; and
- c) article 4 shall not apply to any vehicle being used in connection with the said works or by, or with the permission of, a traffic officer in uniform

7. The M42 Motorway and A45 Trunk Road (M42 Junction 6, Solihull) (Temporary Restriction and Prohibition of Traffic Order 2014 (a) is hereby revoked.
