**ROAD TRAFFIC**

**The A45 and A452 Trunk Roads (Stonebridge) (Temporary  
Prohibition of Traffic) Order 2014**

*Made - - - - 19th February 2014*

*Coming into force - - 26th February 2014*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A45 Trunk Road (“the A45”) and A452 Trunk Road (“A452”), is satisfied that traffic on lengths of those roads, at Stonebridge, in the County of Warwickshire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A45 and A452 Trunk Roads (Stonebridge) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 26th February 2014.

2. In this Order:

“Stonebridge Island” means the circulatory carriageway of the A45/A452 roundabout junction at Stonebridge;

“the trunk road” means -  
a) the eastbound carriageway of the A45 from its junction with the slip road leading to Stonebridge Island to its junction with the slip road leading from Stonebridge Island;  
b) the westbound carriageway of the A45 from its junction with the slip road leading to Stonebridge Island, to its junction with the slip road leading from Stonebridge Island;  
c) the circulatory carriageway of Stonebridge Island from its junction with the slip road leading to the eastbound carriageway of the A45, to its junction with the slip road leading from the westbound carriageway of the A45; and

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1.

d) the circulatory carriageway of Stonebridge Island from its junction with the slip road leading to the westbound carriageway of the A45, to its junction with the slip road leading from the eastbound carriageway of the A45.

“the works period”

means the period starting at 22:00 hours on Wednesday 5th March 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road, or the parts of the circulatory carriageway of Stourbridge Island as described in 2 c) and d).

**4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle-

- (a) being used for police, fire brigade or ambulance purposes;
- (b) proceeding at the direction of, or with the permission of, a police constable; or
- (c) being used in connection with the said works.
