ROAD TRAFFIC

**The M62 Motorway (Junction 34 to Junction 38)
(Temporary Prohibition of Traffic) Order 2015**

Made - - - - *19th February 2015*

Coming into force - *1st March 2015*

WHEREAS, the Secretary of State for Transport, being the traffic authority for the M62 Motorway, M18 Motorway and connecting roads, in the Counties of North Yorkshire and Humberside, is satisfied that traffic on that motorway and some of those connecting roads should be prohibited because road marking and other routine maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order:

1. This Order may be cited as the M62 Motorway (Junction 34 to Junction 38) (Temporary Prohibition of Traffic) Order 2015 and shall come into force on 1st March 2015.

2. Subject as mentioned in article 3 of this Order, no person shall, during a period of 10 hours starting at 20:00 hours on Monday 2nd March 2015 or any subsequent night thereafter until the said works have been completed, cause or permit any vehicle to enter or proceed in the:

- (i) M62 Motorway eastbound carriageway from the nose of the exit slip road at Junction 34 (Whitley) eastwards to the nose of the entry slip road at Junction 35 (Langham), a distance of 13700 metres;
- (ii) M62 Motorway eastbound carriageway from the nose of the exit slip road at Junction 36 (Airmyn) eastwards to the nose of the entry slip road at Junction 38 (North Cave), a distance of 18260 metres;
- (iii) M62 Motorway westbound carriageway from the nose of the exit slip road at Junction 38 westwards to the nose of the entry slip road at Junction 36, a distance of 18290 metres;
- (iv) M62 Motorway westbound carriageway from the nose of the exit slip road at Junction 35 westwards to the nose of the entry slip road at Junction 34, a distance of 13300 metres;
- (v) M62 Motorway eastbound entry slip road at Junction 34;
- (vi) M62 Motorway eastbound entry slip road at Junction 36;
- (vii) M62 Motorway eastbound entry slip road at Junction 37;
- (viii) M62 Motorway westbound entry slip road at Junction 38;
- (ix) M62 Motorway westbound entry slip road at Junction 37; or
- (x) link road connecting the M18 Motorway northbound carriageway to the M62 Motorway westbound carriageway at Langham (M18 Junction 7 and M62 Junction 35).

3. The provisions of article 2 of this Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;

- (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
