ROAD TRAFFIC

The A50 Trunk Road (Uttoxeter to Sudbury) (Temporary Prohibition of Traffic) Order 2015

Made - - - - 9th March 2015

Coming into force - - 16th March 2015

WHEREAS the Secretary of State for Transport, being the traffic authority for the A50 Trunk Road (“the A50”) and connecting roads, is satisfied that traffic on a length of that road and three of those connecting roads, between Uttoxeter and Sudbury in the Counties of Staffordshire and Derbyshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A50 Trunk Road (Uttoxeter to Sudbury) (Temporary Prohibition of Traffic) Order 2015 and shall come into force on Monday 16th March 2015.

2. In this Order:

“the trunk road”

means –

- a) the eastbound carriageway of the A50 from the roundabout junction with the A518/B5030 Ashbourne Road, Uttoxeter, to the junction with the slip road leading from the dumbbell roundabout junction with the A515, Derby Road and Main Road, north west of Sudbury; and
- b) the westbound carriageway of the A50 from the roundabout junction with the A515 and Aston lane (Sudbury Roundabout), to the roundabout junction with the A518/B5030 Ashbourne Road, Uttoxeter;

“a slip road”

means the slip road leading to –

- a) the westbound carriageway of the A50 from the dumbbell roundabout junction with the A515, Derby Road and Main Road;

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1.

- b) the westbound carriageway of the A50 from Marston Lane, Doveridge; and
- c) the eastbound carriageway of the A50 from the dumbbell roundabout junction with the A515, Derby Road and Main Road;

“the works period” means the period starting at 20:00 hours on Thursday 19th March 2015 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- 3. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or a slip road.

- 4. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or leave the circulatory carriageway of the A50/A518 roundabout, north east of Uttoxeter, at its junction with –
 - a. Noah’s Ark farm access road; or
 - b. the A518 Derby Road.

- 5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle –
 - (a) being used for police, fire brigade or ambulance purposes;
 - (b) proceeding at the direction of, or with the permission of, a police constable; or
 - (c) being used in connection with the said works.
