**ROAD TRAFFIC**

**The A34 Trunk Road (Near Oxford) (Temporary Prohibition of Traffic) Order 2015**

*Made* - - - - - *9th March 2015*

*Coming into force* - - - - - *28th March 2015*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A34 Trunk Road and connecting roads, is satisfied that traffic should be prohibited on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

**1.** This Order may be cited as the A34 Trunk Road (Near Oxford) (Temporary Prohibition of Traffic) Order 2015 and shall come into force on 28th March 2015.

**2.** In this Order:

“the trunk road” means the A34 Trunk Road in the County of Oxfordshire;

“a slip road” means all roads leading to and from the trunk road at West Ilsley Interchange, Chilton Interchange (A4185), Milton Interchange (A4130), Marcham Interchange (A415), A4183/Oxford Road Interchange, Hinksey Hill Interchange (A423), Botley Interchange (A420), Peartree Interchange (A44), Kidlington Interchange, Islip Interchange (B4027) and Weston on the Green Interchange (B430);

“a side road” means Westminster Way, the road leading to South Hinksey village (south of Westminster Way), Wytham Side Road, North Hinksey Lane, the road leading to South Hinksey village (south of North Hinksey Lane), Southern By-Pass side Road and Stanley Close at its Junction with the trunk road;

“works” means road marking, resurfacing, vegetation clearance, bridge works, sign works and all associated work; and

“a works period” means a period of 8 hours starting at 2200 hours on Monday 30th March 2015 or on any subsequent day until 27th September 2016.

**3.** Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in a slip road or a side road.

**4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -

(a) a vehicle being used in connection with the said works;

- (b) a vehicle being used for police, ambulance, traffic officer or fire and rescue authority purposes;
- (c) any vehicle being used for winter maintenance purposes;
- (d) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
- (e) a vehicle proceeding in a side road to or from premises accessible from, and only from, that road to such extent as shall be indicated by traffic signs.
