**The Air Navigation (Restriction of Flying) (Birmingham) (No. 3) Regulations 2022**

*Made* - - - - *5th September 2022*

*Coming into force* - - *23rd September 2022*

The Secretary of State has decided that it is in the public interest to restrict the flying of unmanned aircraft in the area specified in regulation 3(1) by reason of the intended holding there of Birmingham Pride.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

**Citation and commencement**

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Birmingham) (No. 3) Regulations 2022 and they come into force on 23rd September 2022.

**Interpretation**

2. In regulation 3(1) the times referred to are Co-ordinated Universal Time(b).

**Restricted airspace**

3.—(1) Subject to paragraph (2), between 0600 hours on 23rd September 2022 and 2300 hours on 24th September 2022 no unmanned aircraft is to fly below 800 feet above mean sea level within the area bounded by a circle having a radius of 0.5 nautical miles whose centre is at 522835N 0015347W.

(2) Paragraph (1) does not apply to any unmanned aircraft flying in accordance with a permission granted by the West Midlands Police Service.

## **EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations impose restrictions on the flying of unmanned aircraft in the vicinity of Birmingham City Centre during Birmingham Pride that is scheduled to take place on 23rd and 24th September 2022. In view of the high visibility of this event and at the request of the West Midlands Police Service, the Civil Aviation Authority and the Department for Transport agree that the flying of unmanned aircraft should be restricted for reasons of public safety and security.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).
