**The Air Navigation (Restriction of Flying) (Scampton)
(Restricted Zone EG R313) (Amendment) (No. 3) Regulations
2023**

Made - - - - *27th July 2023*

Coming into force - - *2nd November 2023*

The Secretary of State has decided that it is necessary in the public interest to amend the restriction of flying for the Scampton Restricted Zone EG R313.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (Scampton) (Restricted Zone EG R313) (Amendment) (No. 3) Regulations 2023 and they come into force on 2nd November 2023.

Amendment of the Regulations

2.—(1) The Air Navigation (Restriction of Flying) (Scampton) (Restricted Zone EG R313) Regulations 2022(b) are amended as follows.

(2) In regulation 3(1), for “between the hours of 0830 to 1700 on each of the five days of Monday to Friday every week, or as notified by Notice to Aviation (NOTAM)(c) outside these hours” substitute “as notified by Notice to Aviation (NOTAM)(c)”.

Revocation of Amendment to the Regulations

3. The Air Navigation (Restriction of Flying) (Scampton) (Restricted Zone EG R313) (Amendment) (No. 2) Regulations 2023(c) are revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Air Navigation (Restriction of Flying) (Scampton) (Restricted Zone EG R313) Regulations 2022 (S.I. 2022/1221, as amended by S.I. 2022/1320, S.I. 2023/234 and S.I. 2023/852) by amending the specific times of the restricted airspace. They also revoke the Air Navigation (Restriction of Flying) (Scampton) (Restricted Zone EG R313) (Amendment) (No. 2) Regulations 2023 (S.I. 2023/852) as the entry into force date of the amendment to Regulation 3 has been changed.

Full details of this Statutory Instrument will be promulgated by Aeronautical Information Circular (AIC) and Notice to Aviation (NOTAM).
