The Norwegian Ambassador at London to the Secretary of State for Foreign Affairs

Sir,

I have the honour to refer to Article 14, paragraph 3, of the Anglo-Norwegian Cultural Convention of the 19th February, 1948⁽¹⁾, concerning the nomination of members of the permanent Mixed Commission set up under that Article, and to inform you that for administrative reasons my Government intend to transfer the responsibility of nominating Norwegian members of the Commission from the Ministry of Ecclesiastical Affairs and Public Instruction to the Ministry of Foreign Affairs.

2. The Royal Norwegian Government accordingly propose that Article 14, paragraph 3, of the above-mentioned Convention should be amended by the substitution of "Det Kgl. Norske Utenriksdepartement" for "Det Kgl. Norske Kirke- og Under-visningsdepartement" in the Norwegian text and of "the Royal Norwegian Ministry of Foreign Affairs" for "the Royal Norwegian Ministry of Ecclesiastical Affairs and Public Instruction" in the English text.

3. If this proposal is acceptable to Her Majesty's Government in the United Kingdom, I have the honour to suggest that the present Note and your Excellency's reply to that effect shall be regarded as constituting an Agreement between the two Governments in this matter.
