Monsieur le Ministre,

Tokyo, August 31, 1955.

Under instructions from Her Majesty's Principal Secretary of State for Foreign Affairs, I have the honour to propose to your Excellency that the Sterling Payments Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of Japan signed in London on the 29th of January, 1954,⁽¹⁾ and extended by an Exchange of Notes dated the 29th of July, 1955,⁽²⁾ until the 31st of August, 1955, shall be further extended for a period of one month to the 30th of September, 1955.

I have the honour further to propose that the arrangements for consultation between the two Governments during the validity of the aforesaid Sterling Payments Agreement provided for in the Exchange of Notes of the 29th of January, 1954, shall also be extended until the 30th of September, 1955.

If the foregoing proposals are acceptable to the Government of Japan I have the honour to suggest that the present Note and your Excellency's reply to that effect should be regarded as constituting an agreement between the two Governments in this matter.
