Your Excellency,

I have the honour under instructions from Her Britannic Majesty's Principal Secretary of State for Foreign Affairs to refer your Excellency to the Air Services Agreement signed in Manila on the 31st of January, 1955<sup>(1)</sup> between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of the Philippines, and to state that, in accordance with the provisions of paragraph 1 of Article 4 of the Agreement, Her Majesty's Government hereby designate Hong Kong Airways, Limited, to operate Route 2 as specified in Schedule II to the Agreement.

Hong Kong Airways would propose to operate three services each week with "Viscount" aircraft. These services would be in addition to those already provided by Cathay Pacific Airways, Limited.

I have the honour to request that the Government of the Republic of the Philippines may grant the appropriate operating authorisation to Hong Kong Airways, Limited.
