PUBLIC OFFICERS' PENSIONS (UGANDA) AGREEMENT 1982—AMENDMENT

I have the honour to refer to the Public Officers' Pensions (Uganda) Agreement 1982 between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Uganda signed at Entebbe on 1 October 1982¹ and in accordance with provisions of Article 1 1(j) (iv) of the Agreement, I have the honour to propose that the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of Uganda might agree that persons detailed at paragraph 2 below shall be deemed to be persons to whom the Agreement shall apply.

Persons listed in Annex A to this letter, being officers who served as civilian employees of the East African Land Forces Organisation and who were either transferred from that service to the service of the Government of Kenya, Uganda or Tanganyika or to the East African High Commission or who secured an appointment with any one of those governments or with the High Commission in either case without any break in service.

Since all EALFO service took place between 1957 and 1969 the cost of pensions in respect of such employment falls to the reimbursement element of the financial settlement to be concluded between the Government of the United Kingdom and the Government of the Republic of Uganda and as such no cost will attach to the Government of the Republic of Uganda.

If the foregoing proposal is acceptable to the Government of the Republic of Uganda, I have the honour to propose that this letter, together with Your Excellency's reply in that sense, shall constitute an Agreement between our two governments on this matter (which shall enter into force on the date of Your Excellency's reply).
