The A55 Trunk Road (Junction 24,
Abergele, Conwy, to Junction 25,
Bodelwyddan, Denbighshire)
(Temporary Prohibition of Vehicles
& 40 mph Speed Limit) Order 2013

Made 28 January 2013

Coming into force 9 February 2013

The Welsh Ministers, being the traffic authority for the relevant length of the Chester – Bangor Trunk Road (A55) (hereinafter referred to as “the trunk road”), are satisfied that traffic in a specified length of the trunk road should be restricted or prohibited by reason of works being executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 9 February 2013 and its title is The A55 Trunk Road (Junction 24, Abergele, Conwy, to Junction 25, Bodelwyddan, Denbighshire) (Temporary Prohibition of Vehicles & 40 mph Speed Limit) Order 2013.

2. —(1) In this Order:

“the length of the trunk road” (“*y darn o’r gefnffordd*”) means the length of the eastbound carriageway of the A55 trunk road between Abergele and Bodelwyddan that extends from the centre-point of the westerly underbridge at Junction 24, Abergele, in the County Borough of Conwy, to the centre - point of the over-bridge at Junction 25, Bodelwyddan, in the County of Denbighshire;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 07:00 hours on 9 February 2013 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Restriction and Prohibition

3. Subject to the provisions of article 5, no person shall, during the works period, drive or cause or permit any vehicle to proceed in the length of the trunk road.

4. Subject to the provisions of article 5, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.

Application

5. The provisions of articles 3 and 4 apply only during such times and to such extent as the application of the restriction and prohibition referred to therein is indicated by traffic signs.

Duration of this Order

6. The maximum duration of this Order shall be 18 months.
