The A470 Trunk Road (Llanrwst,
Conwy) (Temporary Prohibition of
Vehicles, Cyclists and Pedestrians)
Order 2013.

Made 21 January 2013

Coming into force 3 February 2013

The Welsh Ministers, being the traffic authority for the relevant length of the A470 Maentwrog to East of Conwy Trunk Road (hereinafter referred to as “the trunk road”), are satisfied that traffic in a specified length of the trunk road should be prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 3 February 2013. The title to this Order is The A470 Trunk Road (Llanrwst, Conwy) (Temporary Prohibition of Vehicles, Cyclists and Pedestrians) Order 2013.

2.—(1) In this Order:

“the length of the trunk road” (*“y darn o’r gefnffordd”*) means the length of the trunk road specified in the Schedule to this Order.

“works period” (*“cyfnod y gwaith”*) means that period commencing at 05.00 hours on 3 February 2013 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibition

3. Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed in the length of the trunk road specified in the Schedule to this Order.

4. Subject to the provisions of article 6, no person shall, during the works period, ride or cause to be ridden any pedal cycle in the length of the trunk road specified in the Schedule to this Order.

5. Subject to the provisions of article 6, no pedestrian shall, during the works period, proceed in the length of the trunk road specified in the Schedule to this Order.

Application

6. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as the application of the prohibition referred to therein is indicated by traffic signs.

Duration of this Order

7. The maximum duration for this Order shall be 12 months.

LENGTH OF THE A470 TRUNK ROAD AT LLANRWST IN THE COUNTY BOROUGH OF CONWY.

That length of the trunk road from a point on the southern parapet of Pont Fawr at the junction of the A470 and the B5106 to the northern channel of the junction between the A470 and the Victoria Flats.
