The Welsh Ministers, being the traffic authority for the relevant lengths of the Neath – Abergavenny Trunk Road (A465) (hereinafter referred to as "the trunk road"), are satisfied that traffic in specified lengths of the trunk road should be prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2),make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 18 March 2014. Its title is The A465 Trunk Road (Aberdulais Interchange to Neath Abbey Interchange, Neath Port Talbot) (Temporary Prohibition of Vehicles, Pedestrians and Cyclists) Order 2014.

2.—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the lengths of the trunk road" ("y darnau o'r gefnffordd") means the lengths of the A465 Trunk Road in the County Borough of Neath Port Talbot specified in the Schedule to this Order.

"works period" ("cyfnod y gwaith") means that period commencing at 21:00 hours on 18 March 2014 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

Prohibitions

- **3.** Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed along the lengths of the trunk road.
- **4.** Subject to the provisions of article 6, no pedestrian shall, during the works period, proceed in the lengths of the trunk road.
- **5.** Subject to the provisions of article 6, no person shall, during the works period, ride or cause to be ridden, any pedal cycle in the lengths of the trunk road.

Application

6. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as the application of the prohibitions referred to therein are indicated by traffic signs.

Duration of this Order

7. The maximum duration of this Order shall be 18 months.

- 2) The entire length of the westbound on slip road at Aberdulais Interchange.
