The A465 Trunk Road (Llangua to Hardwick Roundabout, Monmouthshire) (Temporary Speed Restrictions & No Overtaking)

Order 2015

29 July 2015

Coming into force

10 August 2015

The Welsh Ministers, being the traffic authority for the relevant lengths of the Newport – Shrewsbury Trunk Road (A465) ("the trunk road"), are satisfied that traffic in specified lengths of the trunk road should be restricted or prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 10 August 2015. Its title is The A465 Trunk Road (Llangua to Hardwick Roundabout, Monmouthshire) (Temporary Speed Restrictions & No Overtaking) Order 2015.

2.—(1) In this Order:

"the lengths of the trunk road" ("y darnau o'r gefnffordd") means those lengths of the trunk road in the County of Monmouthshire specified in the Schedules to this Order;

"works period" ("cyfnod y gwaith") means the period commencing at 09:30 hours on 10 August 2015 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

Restrictions and Prohibition

- **3.** Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the lengths of the trunk road specified in Schedule 1.
- **4.** Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road specified in Schedule 2.
- **5.** Subject to the provisions of article 7, no person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road specified in Schedule 2 during such times as the restriction referred to in article 4 is in operation.

Suspension

6. The provisions of The A465 Trunk Road (Llanvihangel-Crucorney, Werngifford and Pandy, Monmouthshire) (40 MPH & 50 MPH Speed Limits) Order 2003(3) are hereby suspended in respect of the relevant length of the trunk road specified in Schedules 1 and 2 during such times as the restriction specified in articles 3 and 4 of this Order is in operation.

Application

7. The provisions of articles 3, 4 and 5 apply only during such times and to such extent as the application of the restrictions and prohibition referred to therein are indicated by traffic signs.

Duration of this Order

8. The maximum duration for this Order shall be 18 months.

SCHEDULE 1 Temporary 40 mph Speed Limit

The length of the trunk road that extends from a point 97 metres south-west of the centre-point of the access to the dwelling known as Crossing Cottage, near Llangua, in a south-westerly direction to a point 435 metres north-east of the centre-point of the Wern Gifford junction, near Pandy .

The length of the trunk road that extends from a point 330 metres south-west of the centre-point of the Wern Gifford junction, near Pandy, in a southerly direction to the northern tip of the physical traffic island at the A465/A40 junction

SCHEDULE 2 Temporary 10 mph Speed Limit & No Overtaking

The length of the trunk road that extends from a point 97 metres south-west of the centre-point of the access to the dwelling known as Crossing Cottage, near Llangua, in a south-westerly direction to the northern tip of the physical traffic island at the A465/A40 junction.
