## WELSH LANGUAGE

### The Welsh Language (Wales) Measure 2011 (Commencement No. 8) Order 2015

*Made* - - - - - *25 March 2015*  
*Coming into force* - - - *16:00 on 25th March 2015*

The Welsh Ministers, in exercise of the power conferred upon them by section 156(2) of the Welsh Language (Wales) Measure 2011<sup>(1)</sup>, make the following Order:

#### Title and interpretation

- 1.—(1) The title of this Order is the Welsh Language (Wales) Measure 2011 (Commencement No. 8) Order 2015.
- (2) In this Order “Measure” means the Welsh Language (Wales) Measure 2011.

#### Commencement

2. Section 108 of the Measure (enforcement policy document) comes into force at 16:00 on 25 March 2015.
