**The A483 Trunk Road (Cilyrychen
Level Crossing, Llandybie,
Carmarthenshire) (Temporary
Prohibition of Vehicles, Cyclists &
Pedestrians) Order 2016**

Made 4 April 2016

Coming into force 6 April 2016

The Welsh Ministers, as traffic authority for the relevant length of the Swansea – Manchester Trunk Road (A483) (“the trunk road”), are satisfied that traffic in a specified length of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 6 April 2016 and its title is The A483 Trunk Road (Cilyrychen Level Crossing, Llandybie, Carmarthenshire) (Temporary Prohibition of Vehicles, Cyclists & Pedestrians) Order 2016.

2. —(1) In this Order:

“the length of the trunk road” (“*y darn o’r gefnffordd*”) means the length of the trunk road at Llandeilo Road, Llandybie in the County of Carmarthenshire that extends from a point 20 metres north-east of Cilyrychen level crossing to a point 20 metres south-west of the said level crossing;

“works period” (“*cyfnod y gwaith*”) means that period commencing at 21:30 hours on 6 April 2016 and ending when the temporary traffic signs have been permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibitions

3. Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed in the length of the trunk road.

4. Subject to the provisions of article 6, no person shall, during the works period, ride, or cause or permit any pedal cycle to be ridden in the length of the trunk road.

5. Subject to the provisions of article 6, no person shall, during the works period, proceed on foot in the length of the trunk road.

Application

6. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as the application of the prohibitions referred to therein is indicated by traffic signs.

Duration of this Order

7. The maximum duration for this Order shall be 18 months.
