The A40 Trunk Road (Travellers
Rest to Pensarn Roundabout,
Carmarthen, Carmarthenshire)
(Temporary Traffic Prohibitions &
Restrictions) Order 2019

Made 27 August 2019

Coming into force 3 September 2019

The Welsh Ministers, as traffic authority for the A40 Trunk Road, are satisfied that traffic on specified lengths of the trunk road should be prohibited and/or restricted because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. The title of this Order is the A40 Trunk Road (Travellers Rest to Pensarn Roundabout, Carmarthen, Carmarthenshire) (Temporary Traffic Prohibitions & Restrictions) Order 2019 and it comes into force on 3 September 2019.

2. In this Order:

“exempted vehicle” (*“cerbyd esempt”*) means:

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2);

(1) 1984 c.27; section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1. By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c.32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

(2) Section 87 was amended by the Fire and Rescue Services Act 2004 (c.21), Schedule 1, paragraph 55, the Serious Organised Crime and Police Act 2005 (c.15), Schedule 4, paragraph 42, the Crime and Courts Act 2013 (c.22), Schedule 8, paragraph 29(2) and the Deregulation Act 2015 (c.20), section 50(4) and (5).

- (b) any vehicle being used to deliver goods to Tesco, Carmarthen; and
- (c) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A40 London to Fishguard Trunk Road;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 20:00 hours on 3 September 2019 and ending when the temporary traffic signs for each period of works are permanently removed.

Prohibitions and Restrictions

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the lengths of the trunk road specified in Schedule 1 to this Order.

4. No person may, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of the trunk road specified in Schedule 2 to this Order.

5. No person may, during the works period, drive any motor vehicle at a speed exceeding 10 miles per hour on the lengths of the trunk road specified in Schedule 2 to this Order.

6. No person may, during the works period, use any vehicle, other than an exempted vehicle specified in article 2(a) and (c), in such a way that it overtakes any other vehicle on the lengths of the trunk road specified in Schedule 2 to this Order during such times as the restrictions specified in articles 4 and 5 are in operation.

Application

7.—(1) The prohibitions and restrictions in articles 3, 4, 5 and 6 apply only during such times and to such extent as indicated by traffic signs.

(2) . No speed limits imposed by this Order apply to an exempted vehicle specified in article 2(a) and (c).

Suspensions

8. Any statutory provisions restricting the speed of vehicles on the lengths of the trunk road specified in Schedule 2 to this Order are suspended during such times as the restrictions specified in articles 4 and 5 are in operation.

Duration of this Order

9. The maximum duration for this Order is 18 months.

SCHEDULES

SCHEDULE 1

Temporary Prohibition of Vehicles

The length of the eastbound carriageway of the trunk road that extends from its junction with the exit slip road at Travellers Rest to its junction with the north-western side of Pensarn Roundabout.

The length of the westbound carriageway of the trunk road that extends from its junction with the north-western side of Pensarn Roundabout to its junction with the westbound exit slip road to Johnstown.

The length of the trunk road eastbound entry slip road at Johnstown.

SCHEDULE 2

Temporary 40 mph or 10 mph Speed Limits & No Overtaking

The length of the eastbound carriageway of the trunk road that extends from a point 1 kilometre west of the centre-point of Travellers Rest over-bridge to a point 339 metres north-west of its junction with Pensarn Roundabout.

The length of the westbound carriageway of the trunk road that extends from a point 65 metres north-west of its junction with Pensarn Roundabout to a point 500

metres west of its junction with Pont Lesneven Roundabout.
