**The A55 Trunk Road (Junction 8A
(Carreg Bran) & the A5 Trunk Road
(The Lodge to Pentraeth Road
Roundabout, Menai Bridge,
Anglesey) (Temporary Prohibition
of Vehicles, Cyclists & Pedestrians)
Order 2022**

Made 26 April 2022

Coming into force 3 May 2022

The Welsh Ministers, as traffic authority for the relevant lengths of the A55 and A5 trunk roads, are satisfied that traffic on specified lengths of the trunk roads should be prohibited because of works proposed on or near the roads.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. The title of this Order is the A55 Trunk Road (Junction 8A (Carreg Bran) & the A5 Trunk Road (The Lodge to Pentraeth Road Roundabout, Menai Bridge, Anglesey) (Temporary Prohibition of Vehicles, Cyclists & Pedestrians) Order 2022 and this Order comes into force on 3 May 2022.

Interpretation

2. In this Order—

“exempted vehicle” (“*cerbyd esempti*”) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

“the trunk road” (“*y gefnffordd*”) means the A55 and A5 London to Holyhead trunk roads;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 19:00 hours on 3 May 2022 and ending when the temporary traffic signs for each period of works are removed.

Prohibitions

3. No person may, during the works period, drive any vehicle on the lengths of the trunk roads specified in the Schedule to this Order.

4. No person may, during the works period, ride any pedal cycle on the lengths of the trunk roads specified in the Schedule to this Order.

5. No pedestrian may, during the works period, proceed on the lengths of the trunk roads specified in the Schedule to this Order.

Application

6. The prohibitions in articles 3, 4 and 5 apply only during such times and to such extent as indicated by traffic signs.

Duration of this Order

7. The maximum duration of this Order is 18 months.

SCHEDULE

The lengths of the A55 eastbound entry and westbound exit slip roads at Junction 8A (Carreg Bran), Anglesey.

The length of the A5 trunk road that extends from The Lodge, east of Junction 8A to its junction with Pentraeth Road Roundabout, Menai Bridge, Anglesey.
