**ROAD TRAFFIC, WALES**

The A458 Trunk Road (Trewern,  
Powys) (Temporary Prohibition of  
Vehicles, Cyclists & Pedestrians)  
Order 2022

*Made* 15 September 2022

*Coming into force* 26 September 2022

The Welsh Ministers, as traffic authority for the relevant length of the A458 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

**Title and commencement**

1. The title of this Order is the A458 Trunk Road (Trewern, Powys) (Temporary Prohibition of Vehicles, Cyclists & Pedestrians) Order 2022 and this Order comes into force on 26 September 2022.

**Interpretation**

2. In this Order—

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

“the trunk road” (“*y gefnffordd*”) means the length of the A458 Shrewsbury to Dolgellau trunk road that extends from the 40 mph speed limit terminus at the western end of Trewern, Powys to a point 450 metres west of that 40 mph speed limit terminus;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 19:00 hours on 26 September 2022 and ending when the temporary traffic signs for each period of works are permanently removed.

### **Prohibitions**

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road.

4. No person may, during the works period, ride any pedal cycle on the length of the trunk road.

5. No pedestrian may, during the works period, proceed on the length of the trunk road.

### **Application**

6. The prohibitions in articles 3, 4 and 5 apply only during such times and to such extent as indicated by traffic signs.

### **Duration of this Order**

7. The maximum duration of this Order is 18 months.
