ROAD TRAFFIC, WALES

The A470 Trunk Road (Blaenau Ffestiniog and Llan Ffestiniog, Gwynedd) (Temporary Prohibition of Waiting) Order 2025

Made 12 February 2025

Coming into force 13 February 2025

The Welsh Ministers, as traffic authority for the A470 trunk road, are satisfied that traffic on specified lengths of the trunk road should be prohibited by reason of a filming event being held on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 16A of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. The title of this Order is the A470 Trunk Road (Blaenau Ffestiniog and Llan Ffestiniog, Gwynedd) (Temporary Prohibition of Waiting) Order 2025 and this Order comes into force on 13 February 2025.

Interpretation

2. In this Order—

"event period" ("cyfnod y digwyddiad") means intermittent periods commencing at 09:00 hours on 13 February 2025 and ending when the temporary traffic signs for each event period are permanently removed:

"exempted vehicle" ("cerbyd esempt") means—

- (i) any vehicle being used for police, fire or ambulance services purposes;
- (ii) any vehicle being used in connection with works to the road or lighting or traffic signs or emergency works to any sewer or to any main or apparatus for the supply of gas, water or electricity, or telecommunications in, or in any land adjacent to, a length of road concerned;
- (iii) any vehicle used by an authorised event official in support of and for reasons of the safety of the relevant event;

"the trunk road" ("y gefnffordd") means the A470 Maentwrog to East of Conwy trunk road.

Prohibition

3. No person may, during the event period, cause or permit any vehicle to wait in the lay-by or on the sides of the lengths of the trunk road specified in the Schedule to this Order.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Suspension

5. The provisions of article 5 of the A470 Trunk Road (Church Street, High Street and Manod Road, Blaenau Ffestiniog, Gwynedd) (Prohibition and Restriction of Waiting) Order 2018(1) are suspended in respect of the lengths of the trunk road specified in paragraphs 1 and 2 of the Schedule to this Order for the duration of the event period.

Duration of this Order

6. The maximum duration of this Order is 7 days.

SCHEDULE

The length of the lay-by adjacent to the northern side of the trunk road known as Church Street and High Street, Blaenau Ffestiniog that extends from a point 39 metres west of the centre-point of its junction with the road known as Dolgarregddu to a point 21 metres west of the centre-point of that junction.

The length of the northern side of the trunk road known as High Street that extends from the boundary between the properties known as numbers 34 and 35 High Street to a point 20 metres west of the centrepoint of its junction with Lord Street, Blaenau Ffestiniog.

The length of the southern side of the trunk road known as Penybryn, Llan Ffestiniog that extends from the boundary between the properties known as numbers 18 and 19 Penybryn to the boundary between the properties known as numbers 8 and 10 Penybryn.
